RULES & REGULATIONS FOR USE OF THE OAK PARK POOL:

1. The applicant shall be responsible for any damage to equipment or property. If, after any activity additional janitorial maintenance is required, other than the normal cleaning process, the applicant may be charged accordingly.
2. Responsible adults must supervise activities for minors.
3. The lifeguards present are in charge.
4. The posted pool rules must be followed at all times during the course of the activity. The group must also follow the directions of the lifeguard on duty during the course of the scheduled activity.
5. The Pool Manager and/or the lifeguards may reserve the right to cancel the activities at any time if they deem it necessary for safety reasons.
6. No glass beverage containers or kegs are allowed
7. The pool is smoke-free. No smoking is allowed on the pool deck or pool grounds.
8. Illegal drugs are strictly prohibited. Anyone under the influence of drugs or alcohol will be barred from the property.
9. The pool reserves the right to remove any individuals found to be under the influence of drugs or alcohol, or causing an undo disturbance to members, guests, or adjacent homeowners.

3. The undersigned agrees that this release and indemnity agreement has been read and is understood. The undersigned agrees and understands that this release and indemnity agreement is a necessary condition to obtain permission for the private use of the pool.
